### **R v G and others, 2019**

Represented one of four defendants charged with conspiracy to rob a jewellery salesman of £4.1m worth of “chocolate diamond” items. The robbery took place after the retailer, Ernest Jones, advertised his location online.

### **R v P and others, 2019**

Defending in a conspiracy to rob with the use of a firearm and a knife where the victim was attacked in his own home in front of his wife and young children and sustained life-threatening injuries. Following a five week trial and an eight week retrial the defendant was acquitted of robbery, possession of an imitation firearm and causing GBH with intent.

Defended in a conspiracy to steal from William Hill bookmakers by means of an inside man and a fake robbery where the prosecution case was heavily reliant upon telephone evidence. Three week trial.
