His roles focused on policy, safeguarding, and advocacy for children and young people affected by human trafficking, criminal exploitation, and the care system. This background informs his practice and his empathetic, trauma-informed approach to representing young and vulnerable clients.

Defended in proceedings for possession with intent to supply Class A drugs, advancing a defence under the Modern Slavery Act 2015.

### **R v E and O, 2026 - ongoing**

Prosecuting in a multi-handed money-laundering case involving transactions exceeding £500,000.

### **R v K, 2026 - ongoing**

Defending in a blackmail case involving allegations of sharing intimate images without consent.

### **R v A & A, 2025 - ongoing**

Defending in a multi-handed fraud case in which the defendant is alleged to have facilitated the theft of over £50,000 in luxury goods during employment with a global retail brand.

### **R v JW, 2025**

Defended in a burglary case where the trial issue was identification, which involved legal argument on character and an application to dismiss at half time.

Defended in a robbery case where the trial issue was identification.

Defended in a theft case involving alleged breaches of trust by a nurse providing in-patient care.

Defended in a multi-handed domestic burglary trial (total value exceeding £40,000) raising a defence of modern slavery.

Defended in a multi-handed burglary case involving issues of modern slavery and exploitation.

## **R v S, 2026 - ongoing**

Defending in a controlling and coercive behaviour case including allegations of assault occasioning actual bodily harm.

## **R v B (a youth), 2025 - ongoing**

Defending in a possession of an offensive weapon case.

## **R v G, 2025 - ongoing**

Prosecuting in a stalking (fear of violence) case involving two complainants within a domestic context.

## **R v C, 2025**

Defended in an intentional harassment, alarm or distress (racially aggravated) case.

## **R v S, 2025**

Defended in a stalking (fear of violence) case involving allegations of sharing intimate images without consent. Successfully addressed extensive disclosure failings during the trial, resulting in the jury being discharged on an application by the defence.

## Rape and Sexual Offences

### **RL v Chief Officer, 2025**

Represented the Appellant in an appeal against the decision to remove indefinite notification requirements (s.91E of the Sexual Offences Act 2003).

### **R v S, 2025**

Prosecuted in a sexual assault trial involving vulnerable witnesses with significant learning differences and section 28 evidence.

### **R v H, 2025**

Defended in a grievous bodily harm (with intent) trial arising from a bar-fight.

### **R v U, 2025**

Defended in an assault emergency-worker case requiring detailed cross-examination on police conduct and body-worn footage.

### **R v F, 2025**

Defended in a grievous bodily harm (without intent) case in which the defendant, during a psychotic episode (not amounting to insanity), stabbed his housemate with a knife multiple times. Following an acceptable plea to section 20, the defendant received a three-year sentence after the court found he was not dangerous.

### **R v O, 2025**

Prosecuted an assault occasioning actual bodily harm arising from a prison-based altercation involving a member of staff.

Defended in a multiple battery trial involving a physical altercation on an international flight.
