Crime

He is known for a forensic approach to cross-examination, close attention to evidential and legal detail, and an ability to test the prosecution case rigorously. He is frequently instructed in multi-handed cases and matters attracting public or institutional attention.

Extradition

Joshua is regularly instructed in complex extradition proceedings before Westminster Magistrates' Court and the High Court. His extradition practice includes cases raising issues of proportionality, fair trial rights, political motivation, and systemic deficiencies in requesting States.

He is trusted in sensitive matters where courts are required to scrutinise contested evidence, procedural fairness, and the reliability of assurances advanced by requesting authorities. He is known for a measured and forensic approach to extradition advocacy, combining close analysis of international and domestic legal frameworks with sound judgement in cases carrying significant personal, diplomatic, or institutional consequences.

International Criminal Law and Public International Law

Joshua is instructed in international criminal and public international law matters requiring careful analysis of jurisdiction, admissibility, evidential standards, and institutional process. His international practice focuses on advisory and written advocacy work, including the preparation of submissions and amicus curiae interventions in proceedings before international courts and tribunals.

Multi-handed prosecution arising from the escape of detainees from Yarl's Wood Immigration Removal Centre. Acquitted following trial.
