R v Maumbe, 2025

Prosecuted man accused of rape and intentional strangulation. Convicted of all counts.

R v SK, 2025

Defended a man accused of multiple counts of rape and attempted rape. Acquitted of four of five counts of rape/attempted rape.

Defended a man accused of rape after taking a drunk friend home. Acquitted.

Defended a man accused of multiple counts of historic indecent assault on his daughter.

Defended a man accused of Grievous Bodily Harm with intent. The Crown offered no evidence at trial in respect of GBH with intent and proceeded with s.20.

Defended a man accused with another of wounding with intent. Acquitted.

Warwick Crown Court

R v IC, 2022

Defended a man accused of domestic Grievous Bodily Harm with intent. Acquitted.

Inner London Crown Court

R v Winter, 2018

Defended a man accused of Grievous Bodily Harm with intent resulting in a fellow student being blinded by a pool cue. Pleaded to s.20, acquitted after trial of s.18.
